Royalties Agreement

This is an agreement between Carl McMurray / Spiritbuilding Publishing and authors of material published by Spiritbuilding for the purpose of explanation and to avoid confusion.

Articles

1. In exchange for design work, typesetting, proofing, printing and all other processes involved in producing the author's material, Spiritbuilding Publishing shall have the sole right of copyright / license of said work. It may not be turned over to another publisher or released in other ways that would circumvent that right.
 - A. In the interest of producing quality marketable materials Spiritbuilding offers its services in cover design, art and/or photography. One cover design is offered at no cost as part of the production project.
 - B. The author may reject that cover design and is free to pursue or create their own design and submit it for Spiritbuilding's final approval.
 - C. At the author's request Spiritbuilding can develop additional cover designs at the market rate for artists/photographers.
 - D. Clipart, photos, charts, tables, illustrations, and all other graphics must be included or requested when the manuscript is submitted. These cannot be added after the production process has started.
 - E. Author is entitled to five business days after manuscript submission to amend manuscript, change graphics, or otherwise request production changes. After that time changes will not be accepted.
 - F. At the author's request a proof copy can be provided in PDF format before going to print. After printing first edition, revisions will be charged a fee of \$50.
 - G. Production on the author's project will begin when this contract is signed and submitted.
2. If no specified time is noted by the author, copyright will remain in possession, and royalties will be paid out to author as long as Spiritbuilding continues to print the material.
3. Royalties agreed upon will be paid annually by Spiritbuilding. Author may choose, at their discretion, to receive royalty amounts in printed materials of their choice figured at the general wholesale rate of 40% discount. They also may have royalties assigned by will, or sent to estate, trust, or party of their choosing.
4. Royalties will be paid on the basis of the "sold" price of material. The "sold" price of material may be

full retail, discounted pricing, or wholesale [trade discount]. No royalties are paid on samples or free gifts.

5. Standard trade discounts of 40% will be given to bookstores purchasing material for resale. Authors may purchase their own material at trade discount at any time. No royalties are paid on materials purchased by the author at trade discount.
6. In the event of Spiritbuilding dissolving or changing ownership, every effort will be made to honor these royalty agreements. If unable to do so, author will be notified that contract is void and material copyright will pass to author solely. Unsold material will be sold or transferred to new owner making every attempt to do so in a manner acceptable to both the author and Spiritbuilding.
7. In the event of an author's death, royalties will continue to be paid to the estate or heirs as directed. If no wishes are communicated to Spiritbuilding, copyright & royalties will pass and remain to Spiritbuilding solely, so that material may continue to be published.
8. Spiritbuilding reserves the right to refuse reprinting if at any time the material is deemed offensive or not marketable. If such happens, Spiritbuilding will release the copyright back to author, although design work, graphics, etc. created by Spiritbuilding remain the property of Spiritbuilding and cannot be used in another publication.
9. Spiritbuilding's pledge is that we will try at all times to deal with authors (and customers) fairly and in the same way that we want to be treated. That is more important to us than binding anyone legally to the articles above.
